General Conditions 简章

IMAGE AND ENTRY REQUIREMENTS This exhibition is open to anyone; however, an entry may be rejected when the Sponsor or the Exhibition Organizers, in their reasonable discretion, believes the entry does not conform to exhibition rules and these Conditions of Entry. Membership in any photographic organization is not required.

图片和参加要求：本次影展（国际摄影艺术展览）开放给各界摄影爱好者；但是，如果主办方（新加坡影艺研究会）在合理判断下认为参赛作品不符合影展规则和参赛条件，有权拒绝违规的参赛作品。参赛不需要任何摄影组织的会员资格。

Sanctions: Entries will not be accepted from any entrant who is currently sanctioned by PSA.

制裁：不接受任何目前受到美国摄影学会制裁的参赛者的参赛作品。

PSA Star Ratings

To receive proper Star ratings credit from PSA, entrants must provide their names and country exactly the same in each exhibition. Aliases are not permitted. Please contact PSA in the event of name changes or relocating to another country. Using one's name differently in different exhibition exposes the entrant to the risk that many of their acceptances may not be recognized by PSA Star Ratings

Image Creation

Entries must originate as photographs (image-captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally.

图像创作：参赛作品必须来自参赛者在感光乳剂上制作或以数字方式获得的照片（通过感光度对物体进行图像捕捉）。

Certification:

By virtue of submitting an image, the entrant certifies the work as his or her own (Images may not incorporate elements produced by anyone else (for example: clip art, images or art by others downloaded from the Internet). Aliases are not allowed. The entrant permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. Note: Entrants who indicate that their images may not be reproduced or used "will not be eligible for awards" or inclusion in audio-visuals of the exhibition "and could be subject to disqualification" by the exhibition sponsors. The exhibition assumes no liability of any misuse of copyright

认证：参赛者一旦上传作品，即表示该作品为作者所创作，作品版权属作者所拥有。作品不得包含其他人的素材（例如剪贴画、图像或艺术图片从网络下载的素材等），不允许使用别名，参赛者必须允许赞助或主办组织免费使用其参赛作品用于出版、展览、媒体、网络宣传等，这亦包括提供低解析度作品于网上发表。注意：作者如有明确声明其作品得复制、转载或使用，主办组织有权取消其参赛资格。主办组织不承担任何著作权被盗用的责任。

Alteration and Computer Generation Subject to Divisional restrictions (particularly Nature, Photo Travel, and Photojournalism) images may be altered, either electronically or otherwise, by the maker. Adjustments to enhance images or creatively modify images are allowed providing the underlying photograph is retained in a way that is obvious to the viewer. Images may not be constructed entirely with a computer, and must be the sole work of the author

图片编辑、电脑后制：在遵守各个组别规则限制的大前提下（特别是自然、旅游和报道摄影）作者可能会利用电脑技术适当地修改及有创意地修饰作品的元素，以提高作品的观赏性和吸引力，但必须保留原本的内容。影像不能是完全电脑制作，参赛作品版权仍属作者所有。

Re-use of accepted images: Once an image has been accepted in this exhibition it may not be entered again in any future instances of this exhibition. It may, of course, be entered in any other PSA/FIAP recognised exhibitions but **must always have the same title.**

Entry: An Entry consists of, up to and including, four (4) images entered by a single entrant into the same Section. An entrant may only enter a specific Section once.

提交作品: 每位参赛者只能参加每个组别一次, 每组最多提交四张作品。

Titles:

Each image must have a unique title **that is a description of the image**. That unique title must be used for entry of that image or of an identical Image into any and all PSA-Recognized exhibitions. Titles must be 35 characters or fewer. No titles may be visible to the judges, and nothing in the image may identify the maker. Titles may not include file extensions such as .jpg or .jpeg (or any other camera capture filenames such as IMG 471). Titles may not consist of personal identifiers possibly augmented by a number; or include words such as “untitled” or “no title”. Titles may not consist solely of numbers unless those numbers are prominently contained within the image, such as a contestant number in a race.

标题: 每幅作品只能使用一个唯一标题, 该唯一标题必须用于将该图像或相同图像投稿于美国摄影学会认证的任何或所有影展使用。而且标题最长不得超过 35 个字符。作品中不能存有任何标题、记号能令评委识别作者。标题中不得包含文件扩展名, 例如 .jpg 或 .jpeg (或任何其他相机拍摄的文件名称, 如: IMG 471), 也不得包含如「无标题」或「没有标题」之类的词。标题不能仅由数字组成, 除非这些数字显著地包含在图像中, 例如比赛中的参赛者编号。

Color and Monochrome:

Color and Monochrome images from the same capture that share substantial pictorial content in common will be considered the same image and must be given the same title.

The Exhibition will be conducted in accordance with the rules of the PSA and FIAP

An entrant's images will not be presented to the judges consecutively. An entrant's four images will be distributed throughout four rounds of judging in that section. Distribution of images will be in the same round order as submitted by the entrant.

DATA PROTECTION

By entering this exhibition, you are explicitly consenting to the personal details you have supplied, including email addresses, being held, processed and used by the exhibition organizers for purposes associated with this exhibition. You also explicitly consent to such information being sent to organizations that have accorded official recognition, patronage or accreditation to this exhibition. You acknowledge and accept that entering this exhibition means that the status and results of your entry may be made public.

- The contest is carried out in accordance with the rules of FIAP (International Federation of Photographic Art) and PSA (Photographic Society of America).

这次比赛是按照 FIAP (国际影艺联盟) 和 PSA (美国摄影学会) 的规则进行的。

- By the sole act of submitting his/her images or files to a salon under FIAP/PSA Patronages, the entrant accepts without exception and with no objection that the submitted images can be investigated by FIAP/PSA to establish if these obey FIAP/PSA regulations and definitions even if the entrant is not a member of FIAP/PSA; that FIAP/PSA will use any means at its disposal for this undertaking; that any refusal to cooperate with FIAP/PSA or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP/PSA and that in case of sanctions following the non compliance with FIAP/PSA regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations.

- Works accepted will count for the PSA Star-rating, Who's Who in Photography, FIAP and FAPA distinctions and GPU Crowns.

- Each entrant may submit in all 5 sections, up to 4 entries per section.

- All entries must be submitted in digital JPEG format with a maximum horizontal dimension of 1920 pixels and maximum vertical dimension of 1080 pixels. Please keep compressed file size to no more than 4MB.

全部作品必须以 JPEG 格式提交。图像宽不可超过 1920 像素，高不可超过 1080 像素。作品的文件以 4MB 为限。

- Judging will be conducted on site if circumstances permit. Otherwise, it will be done on line. An entrant's 4 images will be distributed throughout four rounds of judging in that section.

- The judging of the images will be through HDTV screens with resolutions of 1920 by 1080 or 4K pixels. Screens will be color-calibrated and the images will be shown at 100% of the image resolution.

评审将用分辨率为 1920X1080 或 4K 像素的全高清电视屏幕进行，屏幕将进行颜色校准，图像将以 100% 的图像分辨率显示。

- Please use sRGB Colour Space as it will provide better quality under the projection conditions used for judging and producing the exhibition show.

- Any image previously accepted in the Singapore Photo-Art International Exhibition is not eligible for submission.

任何曾经获得入选新加坡影艺研究会主办的国际艺术摄影展览的作品，一律不准再次提交。

- An image that was accepted in a prior CPID recognized section of this exhibition may not be entered in a PID recognized Colour section of this exhibition.

- Late entries shall not be judged.

Definitions 定义

SUBJECT MATTER AND SECTION DEFINITIONS

Statement on Subject Matter applicable to all sections

The fundamental rule that must be observed at all times and applies to all sections offered in exhibitions with FIAP patronage or PSA recognition is that **the welfare of living creatures is more important than any photograph**. This means that practices such as baiting of subjects with a living creature and removal of birds from nests, for the purpose of obtaining a photograph, are highly unethical, and such photographs are not allowed in any exhibition with FIAP patronage or PSA recognition. Under no circumstances may a living creature be placed in a situation where it will be killed, injured or stressed for the purpose of obtaining a photograph. This rule applies regardless of whether or not the creature being killed, injured or stressed is visible in the captured image.

There are also concerns about the use of aerial photography, drones, helicopters, low flying aircraft. These should not cause any interference with other individuals or animals which causes a disturbance in their normal activity or disrupt the way any individuals or animals interact with their environment.

Entry in this exhibition is conditional on accepting these policies. The content of images must comply with these General Conditions and with the Division and Section definitions listed in these conditions. Images that - in the sole opinion of the judges or the Exhibition Organizers - do not comply, will be disqualified so the entrant may be aware of the problem when considering entry into other exhibitions with FIAP patronage/PSA recognition.

拍摄对象和组别定义

适用于所有组别的关于拍摄对象的声明

这个基本规则适用于所有的 FIAP 赞助或美国摄影学会认可的影展：即拍摄对象的权益比相片更重要。这就是说，为了获得照片而用活生物作诱饵，或把雀鸟从巢中取出等这类做法是极不道德的，并且此类照片不允许出现在任何获得 FIAP 赞助或美国摄影学会认可的展览中。在任何情况下，都不得为了获得照片而将动物置于会被杀死、受伤或受到压力的环境中。此规则适用于无论动物是否被杀害、受伤或是拍摄的图像中显示有明显的压力。

也有人担心使用航拍、无人机、直升机、低空飞行器，这项政策的目的是尽量减少航拍对其他人或动物造成的干扰，以免影响他们的正常活动和打乱了他们与环境的和谐共处。

参赛作品必须遵守这些参赛规则和定义，参加本次影展则表示您接受这些规则要求。图像的内容必须符合简章规定和相关组别罗列的定义。违规的作品将随时被影展评委取消参赛资格，在参加由 FIAP 赞助或美国摄影学会认可的其他影展时，参赛者需要认真对待这个问题。

Colour Open 彩色

Any image that satisfies the general rules may be submitted in the Colour Open section. Images that depict nature or travel themes, or are in monochrome, and are submitted in this section will be judged solely on their pictorial merit. Images that have been manipulated extensively should be submitted in the Creative section.

满足一般规则的任何图像都可参加彩色公开组。自然或旅游主题，或单色的图像若提交到这一组，将以其图案的价值评审。过度修改的图像应提交创意组。

Monochrome Open 黑白 (单色)

PSA Monochrome Definition

An image is considered to be Monochrome only if it gives the impression of having no color (i.e. contains only shades of grey which can include pure black and pure white) OR it gives the impression of being a greyscale image that has been toned in one color across the entire image. (For example by Sepia, red, gold, etc.) A greyscale or multi-colored image modified or giving the impression of having been modified by partial toning, multi-toning or by the inclusion of spot coloring does not meet the definition of monochrome and shall be classified as a Color Work.

For the purpose of this exhibition, only greyscale images are allowed in monochrome sections. Toned images are not allowed

美国摄影学会的「单色」作品定义

只有当图像给人没有颜色的印象（即只包含灰色的阴影，其中可以包括纯黑色和纯白色），或者它给人的印象是一幅灰度图像，在整个图像中都是—种色调，它才被认为是单色图像。（例如棕褐色、红色、金色等）。灰度或多色图像被修改或给人的印象是局部着色、多重着色或斑点着色的图像，不符合单色的定义，应被归类为彩色作品。

就本次展览而言，单色部分只允许使用灰度图像。不允许使用色调图像。

Creative Colour 彩色创意

There are no restrictions on subject matter for this creative section. This section allows the photographer freedom to explore the possibilities of photographic art through the extensive manipulation of images and the combination of images, but the photographic content must predominate. An entrant may alter images either digitally or otherwise, if the photographic content predominates.

Additional content or layers must be the original work of the entrant. Images created totally electronically (with no photographic origin) are specifically excluded. Only colour images are acceptable.

这个创作部分没有限制主题。这一部分允许摄影师自由通过广泛的图像处理 and 图像组合来探索摄影艺术的可能性，但摄影内容必须占主导地位。参赛者也可以通过不同手段如数码来改变图像，并可加入自创的美术或数码图像，只要摄影内容占主导地位。

附加内容或图层必须是参赛者原创作品。完全以电子方式创建的图像（完全没有摄影元素）则不被接受。这组仅接受彩色图像。

Nature (Mono/Colour) 自然（彩色/单色）

PSA/FIAP Nature Definition

Nature photography records all branches of natural history except anthropology and archaeology. This includes all aspects of the physical world, both animate and inanimate, that have not been made or modified by humans.

Nature images must convey the truth of the scene that was photographed. A well-informed person should be able to identify the subject of the image and be satisfied that it has been presented honestly and that no unethical practices have been used to control the subject or capture the image. Images that directly or indirectly show any human activity that threatens the life or welfare of a living organism are not allowed.

The most important part of a Nature image is the nature story it tells. High technical standards are expected and the image must look natural. Adding a vignette or blurring the background during processing is not allowed.

Objects created by humans, and evidence of human activity, are allowed in Nature images only when they are a necessary part of the Nature story.

Photographs of human-created hybrid plants, cultivated plants, feral animals, domesticated animals, human-created hybrid animals and mounted or preserved zoological specimens are not allowed.

Images taken with subjects under controlled conditions, such as zoos, are allowed.

Controlling live subjects by chilling, anaesthetic or any other method of restricting natural movement for the purpose of a photograph is not allowed.

No modification that changes the truth of a Nature image is allowed. Images may be cropped but no other technique that removes, adds or moves any part of the image is allowed.

Techniques that remove elements added by the camera, such as dust spots, digital noise and lens flare are allowed.

Complete conversion of colour images to greyscale monochrome is allowed. Partial conversion, toning and infrared captures or conversions are not allowed.

Images of the same subject that are combined in-camera or with software by focus stacking or exposure blending are allowed.

Multiple images with overlapping fields of view that are taken consecutively and combined in-camera or with software (image stitching) are allowed.

Borders

For the purpose of this exhibition any border added to a Nature digital file must be a single border of white or grey, no greater than 3 -5 pixels in width.

PSA/FIAP 「自然摄影」作品的定义

自然摄影记录了自然的历史的所有分支，除了人类学和考古学。这包括物理世界的所有方面，包括有生命的和无生命的，不是由人类制造或修改的。

自然摄影图像必须传达所拍摄场景的真实性。见多识广的人应该能够识别图像的主题，并确信图像是诚实呈现的，并且没有使用不道德的做法来控制主题或捕获图像。不允许直接或间接显示威胁生物体生命或福利的任何人类活动的图像。

自然摄影图像最重要的部分是它讲述的自然故事。需要高技术标准，图像必须看起来自然。不允许在处理过程中添加小插图或模糊背景。

人类创造的物体和人类活动的证据，只有在它们是自然故事的必要组成部分时才被允许出现在自然图像中。

不允许拍摄人造杂交植物、栽培植物、野生动物、驯养动物、人造杂交动物以及镶嵌或保存的动物标本。

具有受控的条件下，如动物园下拍摄的图像，是允许的。

不允许通过冷却、麻醉或任何其他限制自然运动的方法来控制拍摄对象。

不改变自然图像的真相的修改是允许的。可以裁剪图像，但不允许使用其他技术删除、添加或移动图像的任何部分。

允许使用去除由相机添加的元素（例如灰尘点、数字噪声和镜头眩光）的技术。

彩色图像灰度单色的完全转化是允许的。部分转化，色调和红外线捕获或转换是不允许的。

被组合在相机或与由焦点堆叠或曝光共混软件的同一对象的图像是允许的。具有重叠的视场被连续地取出并结合在相机或软件（图像拼接）的多个图像是允许的。

边框

本次影展，自然组的数码图像文件添加的任何边框必须是白色或灰色的单边框，宽度不超过 3-5 像素。

Travel (Mono/Colour) 旅游（彩色/单色）

PSA Photo Travel Definition

A Photo Travel image expresses the characteristic features or culture of a land as they are found naturally. There are no geographical limitations. Images from events or activities arranged specifically for photography, or of subjects directed or hired for photography are not permitted. Close up pictures of people or objects must include features that provide information about the location.

Techniques that add, relocate, replace or remove any element of the original image, except by cropping, are not permitted. The only allowable adjustments are removal of dust or digital noise, restoration of the appearance of the original scene, and complete conversion to greyscale monochrome. Other derivations, including infrared, are not permitted. All images must look natural.

PSA 「旅游」摄影定义

旅游摄影图像表达了自然发现的土地的特征或文化。没有地域限制。不允许使用专门为摄影而安排的事件或活动的图像，或为摄影而指导或雇用的对象的图像。人物或物体的特写照片必须包含提供位置信息的特征。

不允许使用添加、重新定位、替换或删除原始图像的任何元素的技术，除非通过裁剪。唯一允许的调整是去除灰尘或数字噪音，恢复原始场景的外观，并完全转换为灰度单色。不允许使用其他衍生物，包括红外线。所有图像都必须看起来自然。

Breaches of Rules 违反参赛规则

FIAP:

The entrant that by the sole act of submitting his/her images or files to a salon under FIAP Patronage, the entrant accepts without exception and with no objection the following terms: - that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP, - that FIAP will use any means at its disposal for this undertaking, - that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP, - that in case of sanctions following the non compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations. If, at any time, it is determined in the reasonable discretion of the exhibition organizer or the judges before, during, or after the judging of an exhibition that an entrant has submitted entries where one or more images may fail to comply with these Conditions of Entry, including the stated definitions, the exhibition organizers reserve the right to delete the entry from the exhibition and void any or all acceptances or awards in connection with the exhibition. Fees may be forfeited or refunded in these circumstances. The entrant acknowledges that the decision of the exhibition organizers or the judges is final.

FIAP : 通过向 FIAP 赞助下的沙龙影展提交他/她的图像或文件的行为，参赛者无一例外且无异议地接受以下条款：

PSA

If, at any time, it is determined in the reasonable discretion of the exhibition organizer or the judges before, during, or after the judging of an exhibition that an entrant has submitted entries where one or more images may fail to comply with these Conditions of Entry, including the stated definitions, the exhibition organizers reserve the right to delete the entry from the exhibition and void any or all acceptances or awards in connection with the exhibition. Fees may be forfeited or refunded in these circumstances. The entrant acknowledges that the decision of the exhibition organizers or the judges is final

In order to ensure that images comply with the Conditions of Entry and definitions, the exhibition organizers may carry out reasonable measures to verify that:

- a) the images are the original work of the entrant and
- b) the images comply with the rules and definitions as set out in these Conditions of Entry

These steps include, but are not limited to, questioning any entrant, requiring the submission of RAW files or other digital files representing the original capture of the submitted image(s), confronting the entrant with evidence that one or more submitted images fails to comply with the Conditions of Entry (also known as Entry Rules), and offering the entrant a reasonable opportunity to provide counter evidence to refute the exhibition organizer's evidence by a set deadline. Such entries that are not cleared or are still questionable after the entrant has presented evidence may be considered in breach of these Conditions of Entry, and declined. Such entries may be referred to PSA for further investigation of possible ethics violations

PSA retains the right to investigate in any way all complaints/suspensions of breaches of entry conditions, impose sanctions if deemed necessary, void the acceptances of any image found to violate the PSA rules, include the entrant's name on the list of sanctions provided to Exhibitions, and share such investigations with FIAP. Entrants automatically agree to these terms by the act of entering the Exhibition and agree to cooperate with any investigation.

If another party is submitting images on the entrant's behalf, the entrant will still be held responsible for adhering to these Conditions of Entry (Entry Rules) **and will be subject to sanction for any violations** to these Conditions of Entry and PSA's Statement of Ethics that may result. If another party is processing images for an entrant or submitting images on the entrant's behalf, the entrant will still be held responsible for adhering to all Conditions of Entry including the specific conditions in the relevant definitions.
